

Boy's Night Out (BNO) League

Terms and Conditions for Online Payments

1. General

- a. These terms and conditions apply to all payments made online to Boy's Night Out.
- b. By making a payment to Boy's Night Out, you accept these terms and conditions.
- c. Boy's Night Out may amend these terms and conditions at any time by posting the amendment on its website at least 30 days prior to the effective date of change.

2. Definitions

As used in these terms and conditions:

- a. "Boy's Night Out," "we," or "us" refers collectively to Boy's Night Out.
- b. "You" means you, the customer/bowler.
- c. "Service" means the payment service provided by Boy's Night Out.
- d. "Online Payments" includes any method of payment, credit cards, debit cards, PayPal accounts.

3. Authorization

By using the PayPal payment system:

- a. You are stating that you are an authorized user of the method of payment and the information entered is accurate.
- b. You authorize Boy's Night Out to charge the amount you have selected to your method of payment choice.
- c. You also authorize Boy's Night Out to return to your method of payment any funds due to you by Boy's Night Out resulting from the use of this Service.

4. Charges

- a. For each transaction, in addition to the charge you have authorized, your credit card issuer and network may assess their customary transaction or handling charge, if any.
- b. If a charge is declined or reversed by the credit card issuer or network, you agree to pay us a service charge and to reimburse us for all reasonable costs of collection. Your credit card issuer may also assess its customary charge for such transactions.

5. Dishonored Requests for Payments

- a. If your credit card issuer or network does not honor an online payment transaction, then we have the right to charge the amount of any such transaction to your account or to collect the amount from you in cash.
- b. If your credit card issuer or network does not honor an online payment transaction, we may terminate any or all Service, and we may cancel your right to participate in the online payment program.

6. Confirmation of Payment

- a. By clicking “Pay Now,” you are consenting to receive a one-time confirmation of this payment electronically to the email address you have provided to us.
- b. Payments must be made by Monday, 11:59pm EST in order for payment to count for Tuesday.
- c. Payments made on Tuesday (day of) will count for the following week and you will be placed into arrears if funds cannot cover the missed payment.

7. Technical Requirements for Payments

- a. Boy’s Night Out is not required to provide paper copies of any online transactions you have previously authorized.
- b. You agree to provide us, and keep current, a valid email address. If any communication is returned to us as undeliverable, you agree that we may (but are not required to) deliver such communication in paper form to the most recent mailing address you have provided for your account information.
- c. By authorizing an online payment, you confirm that you have the capability to access and download or print electronic disclosures, and that your email address is current and valid.
